No.TAD/BC/717/2013/223: In the interest of public service and with a view to confer greater functional and financial autonomy to the Assam Institute of Research for Tribals and Scheduled Castes, the Governor of Assam is pleased to notify setting up a Society in the name and style of the **Assam Institute of Research for Tribals and Scheduled Castes Society**.

The Society will be formed and will function in accordance with the provisions of the Memorandum of Association (MoA) and the Rules and Regulations framed for this purpose, copy of which are enclosed herewith, and shall be registered under the Societies Registration Act, 1860 (Act No.XXI of 1860) subject to the Rules and Regulations of the Society, the management, supervision and control of the affairs of the Society shall vest in the Board of Management having Hon'ble Minister WPT & BC Department as Chairperson. The Executive Committee of the Society having Senior Most Secretary of WPT & BC department shall work under the overall control and superintendence of the Board of Management.

The Governor of Assam is further pleased to notify that the Office of the Director of Assam Institute of Research for Tribals and Scheduled Castes will continue to exist and function and the Officers and Staffs thereof will continue to draw their salaries etc. as before from State Exchequer. However, the services of all such Officers and Staffs shall also be utilized by the Society for discharge of its functions.

The Director, Assam Institute of Research for Tribals and Scheduled Castes will take necessary steps for the formation and functioning of the Society accordingly.
